In terms of Rule 61(1), Rule 62(a) & Rule 73(1) of the J&K Civil Service (Leave) Rules, 1979 read with SRO-346 dated 17.10.2012 & SRO-274 dated 30.05.2013, sanction is hereby accorded to the grant of study leave in favour of Dr. Mohd. Yousuf Kachroo, Medical Officer, District Hospital, Budgam for undergoing FNB in Minimal Access Surgery at SKIMS, Soura, Srinagar for a period of one year (out of two years) in the first instance with immediate effect, subject to the following conditions:-
