As recommended by the J&K Public Service Commission, sanction is hereby accorded to the temporary appointment of following candidates, under OM Category, as Lecturer(s) in the Department of Medicine in Government Medical College, Jammu, in Pay Level-9 (52700-166700), under Jammu & Kashmir Probationer (Condition of Service, Pay and Allowances) and Fixation of Tenure Rules, 2020 notified vide S.O 192 dated 17.06.2020, with immediate effect:-

The Principal GMC, Jammu shall allow the appointees to join only on the production of the following documents/certificates (in original):-

- 1) Date of Birth Certificate.
- 2) Qualification Certificates.
- 3) Certificates from the concerned District Industries Centre (DIC) and District Employment & Counseling Centre to the effect that no loan under any self employment scheme has been taken by the appointee.
- 4) Domicile Certificate
- 5) Health Certificate from the Standing Medical Board.
- 6) Any other documents as required under rules.

The appointment of the candidates shall be subject to the following conditions:-

- i. The candidates shall join within a period of twenty one (21) days from the date of issuance of this appointment order. In case the appointees fail to join within a period of twenty one (21) days from the date of issuance of this appointment order, they shall forego their right to appointment, which shall be deemed to have been cancelled ab-initio without any further notice.

- ii. Verification/genuineness of the qualification certificates from the concerned issuing authorities.
- iii. The salary of the appointees shall not be drawn and disbursed to them unless the satisfactory reports in respect of (ii) above is received in their favour.
- iv. The appointment of the above candidates shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.
- v. The interim arrangements, if any, made on contract/deputation or on academic arrangement basis against the above posts, shall be deemed to have been terminated forthwith.
- vi. The appointment of the above candidates shall further be subject to outcome of the writ petition(s), if any, pending before any Competent Court of competent jurisdiction.
- vii. The inter-seniority of the above appointees shall be as per the merit secured by his/her in the selection process as indicated against each in the select list furnished by the J&K PSC.


