3. Drawing and Disbursing Officer (DDO) shall complete all codal formalities before presentation of bills at the Treasury.
4. Treasury Officers shall not allow parking or drawl of funds in the Civil Deposit without the prior concurrence of the Finance Department.

6. The Director, Sheri-Kashmir Institute of Medical Sciences, Soura, Srinagar shall send the Utilization Certificate (UC) of the funds as early as possible and positively before 31-03-2022 to Government of India under intimation to this department.
7. All the sanctions/ approvals and clearances shall be in place before drawl of money from the treasury.


