Subject: Non-submission of Verification Rolls – Right to forego appointment.

Government Order No. 159 -JK(HME) of 2022

WHEREAS, the Jammu and Kashmir Public Service Commission vide their No. PSC/DR/Consultant/Surgery/H&FW/2019 dated 07.12.2021, No. PSC/DR/Consultant/Pediatrics/H&FW/2019 dated 26.11.2021 and No. PSC/DR/Consultant/Anesthesia/H&FW/2019 dated 27.10.2021 respectively notified the provisional select list of candidates for appointment to the post of Consultant in the disciplines of Surgery, Pediatrics and Anesthesia respectively in the J&K Health & Family Welfare Department;

AND WHEREAS, in pursuance to Government Order No. 528-JK(GAD) of 2021 dated 21.06.2021, notices dated 25.11.2021 and 10.12.2021 were issued in local dailies, for information of all the selectees to submit their verification rolls of Character and Antecedents (in triplicate) in the HRM Branch of Health & Medical Education Department at Civil Secretariat, Jammu/Srinagar within seven days;

AND WHEREAS, the following candidates have failed to submit their Character and Antecedent verification rolls (in triplicate) within the stipulated time period:-

AND WHEREAS, vide Government Order No. 1003-JK(GAD) of 2021 dated 27.09.2021, which has been issued in continuation of Government Order No. 528-JK(GAD) of 2021 dated 21.06.2021, inter-alia, provides as under:

"the candidates whose recommendations is released by the Selection Agency shall submit their verification rolls in triplicate before the appointing authority within a period of 21 days from its release, failing which the candidate(s) shall forego their right to appointment forthwith".

AND WHEREAS, a notice dated 24.02.2022 was also issued in the local dailies, wherein, the above mentioned selectees were advised to submit their verification rolls of Character and Antecedents form (in triplicate) in the HRM Branch of Health & Medical Education Department at Civil Secretariat, Jammu/Srinagar within five days, failing which, it shall be presumed that they are not interested to serve in the department against the said post;

AND WHEREAS, vide this Department's letter dated 24.02.2022, the above mentioned selectees were also advised to submit their Character and Antecedents form (in triplicate) in the HRM Branch of Health & Medical Education Department, Civil Secretariat, Jammu/Srinagar within five days so that the same could be forwarded to Criminal Investigation Department for verification of their character and antecedents;

AND WHEREAS, the above mentioned candidates/selectees have failed to submit their verification rolls before the appointing authority within the stipulated period of twenty one (21) days from the date of release of recommendation. As such they shall have to forego their right to appointment in light of the provision of Government Order No. 1003-JK(GAD) of 2021 dated 27.09.2021.

NOW, THEREFORE, the following candidates, who were recommended by Jammu & Kashmir, Public Service Commission for appointment to the post of Consultant in the disciplines mentioned against each in the Jammu and Kashmir Health & Family Welfare Department, having failed to submit their verification rolls before the appointing authority within a period of twenty one (21) days from the date of release of recommendation, shall forego their right to such appointment, forthwith:-
