Sanction is hereby accorded to the:

- a. purchase of one unit of ambulance by Principal Government Medical College Doda, in relaxation of the austerity measures imposed vide Govt. order No. 321-F of 2021 dated 06.12.2021 out of the available funds under Capex Budget 2021-22.
- b. advance drawl of funds amounting to ₹ 12,13,146/- (Rupees twelve lakhs thirteen thousand one hundred forty six only), by Principal Government Medical College, Doda, out of the available funds under Capex Budget 2021-22 under classification 4210 - 03 - 105 - 0011 - 2453 - New Medical Colleges, Detailed Head 115 - Works released through BEAMS during 2021-22 for affecting the purchase of ambulance by the medical college:

The sanction shall be subject to the following conditions:

1. The vehicles are purchased through Motor Garages Department.
2. No post of driver is created.
3. Purchase is made through Motor Garages Department.
4. Funds are utilized for purchase of Ambulances only.
5. The Chief Accounts Officer, GMC Doda shall vouchsafe the availability of funds under relevant detailed head.
6. All codal formalities for affecting the purchase shall be adhered to.
7. UC's / Red DC Account of the advance drawl shall be furnished to the concerned quarters including A.G within stipulated time.


