- He/She shall retain his/her lien/promotion prospects in his/her own parent department.
- He/She shall have no superior claim over his/her seniors for consideration of promotion after acquiring such higher qualification(s).

- iv. In case, the concerned doctor(s) fails to rejoin back in his/her parent department immediately after completion of such tenure posting/training course, disciplinary proceedings shall be initiated against him/her without any further notice.


