As recommended by the J&K Public Service Commission, sanction is hereby accorded to the temporary appointment of the following candidates as Assistant Professors in the Department of Forensic Medicine, under OM Category, in Government Medical College, Anantnag/ Government Medical College, Baramulla, in Pay Level-11 (67700-208700), under Jammu & Kashmir Probationer (Condition of Service, Pay and Allowances) and Fixation of Tenure Rules, 2020 notified vide S.O 192 dated 17.06.2020, with immediate effect, subject to the following terms and conditions:-

1. The above candidates shall report to the Principal, Government Medical College, Anantnag/ Baramulla (**as the case may be**). In case of failure of the appointees to join within a period of twenty one (21) days from the date of issuance of this appointment order, they shall forego their appointment, which shall be deemed to have been cancelled ab-initio without any further notice.
2. The appointees shall be allowed to join only on production of the following documents/certificates in original:-
 - a) Date of Birth Certificate.
 - b) Qualification Certificates.
 - c) Certificates from the concerned District Industries Centre (DIC) and District Employment & Counseling Centre to the effect that no loan under any self employment scheme has been taken by the appointee.
 - d) Domicile Certificate.
 - e) Health Certificate from the Standing Medical Board.
 - f) Any other documents as required under rules.

3. The appointment of the above candidates as Assistant Professor shall further be subject to the verification/genuineness of the qualification certificates from the concerned issuing authorities. The salary of the appointees shall not be drawn and disbursed to them unless the satisfactory reports in this regard are received in their favour.
4. The appointment of the above candidates shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.
5. The probation of the appointees and Pay & Allowances during probation shall be regulated in
6. terms of the provisions of the Jammu & Kashmir Probationer (Condition of Service, Pay and Allowances) and Fixation of Tenure Rules, 2020, notified vide S.O 192 dated 17.06.2020, read with J&K Civil Services (Classification, Control and Appeal) Rules, 1956.
7. The interim arrangement, if any, made on deputation or on academic arrangement basis against the above posts, shall be deemed to have been terminated forthwith.
8. The appointment of the above candidates shall be subject to outcome of the writ petition(s), if any, pending before any Competent Court of Law.
