- iv. That the stipend, scholarship etc, if any, received by the doctor during study leave is adjusted in his salary and;
- v. The doctor shall execute a bond in Form-6, in terms of the rule 64(3) of the Jammu and Kashmir Civil Service (Leave) Rules, 1979.




