 - c) Certificates from the concerned District Industries Centre (DIC) and District Employment & Counseling Centre to the effect that no loan under any self employment scheme has been taken by the appointee.
 - d) Domicile Certificate
 - e) Health Certificate from the Standing Medical Board.
 - f) Any other documents as required under rules.
3. The appointment of the above candidate as Assistant Professor shall further be subject to the verification/genuineness of the qualification certificates from the concerned issuing authorities. The salary of the appointee shall not be drawn and disbursed to him unless the satisfactory reports in this regard are received in his favour.
