Consequent upon above, it is further ordered that Dr. Afsana Bano, Medical Officer presently on deputation to Government Medical College, Srinagar, is hereby recalled and posted at District Hospital Kulgam and shall look-after the charge of post of Medical Superintendent, District Hospital, Kulgam.

The above arrangement is made purely on temporary basis and subject to the outcome of writ petition(s), if any, pending before the Court(s) of law and shall not confer any right upon the
