The above candidates shall report to the Principal, Government Medical College, Srinagar/Jammu (as the case may be). In case of failure of the appointees to join within a period of twenty one (21) days from the date of issuance of this appointment order, they shall forego their appointment, which shall be deemed to have been cancelled ab-initio without any further notice.

The appointees shall be allowed to join only on production of the following documents/certificates in original:-

2. Qualification Certificates.
3. Certificates from the concerned District Industries Centre (DIC) and District Employment & Counseling Centre to the effect that no loan under any self employment scheme has been taken by the appointee.
4. Domicile Certificate
5. Health Certificate from the Standing Medical Board.
6. Any other documents as required under rules.

The appointment of the above candidates as Lecturer shall further be subject to the verification/genuineness of the qualification certificates from the concerned issuing authorities. The salary of the appointees shall not be drawn and disbursed to them unless satisfactory reports in this regard are received in their favour.

The appointment of the above candidates shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.
