**Subject: Cancellation of appointment of Dr. Maqsood Ahmad Dar,  
Consultant Medicine.**

**Government Order No. 703 - JK(HME) of 2022**  
**Dated: 03 -10.2022**

**WHEREAS**, vide letter No. HME/HRM/64/2019 dated 19.09.2019, referred 22 posts (OM:14, RBA:02, SC:02, ST:02 & SLC:01) of Consultant Medicine to J&K Public Service Commission for making selection of suitable candidates;

**AND WHEREAS**, the J&K Public Service Commission vide letter No. PSC/DR/Consultant/H&FW/2019 dated 06.12.2021, released the selection of Dr. Maqsood Ahmad Dar S/o Abdul Hameed Dar R/o Bul Bul Nowgam, Anantnag alongwith other eligible candidates;

**AND WHEREAS**, among other candidates, the appointment order in respect of Dr. Maqsood Ahmad Dar as Consultant Medicine was issued vide Government order No. 302-JK(HME) of 2022 dated 17.05.2022;

**AND WHEREAS**, one Dr. Jan Mohammad has represented this department for operating of waiting list in his favour due to non-joining of Dr. Maqsood Ahmad Dar as Consultant Medicine;

**AND WHEREAS**, the representation was examined in the Department and accordingly, the matter was taken up with the Director Health Services, Kashmir vide letter No. HME-HRM/109/2021-02 dated 05.07.2022, for seeking his comments with regard to joining of Dr. Maqsood Ahmad Dar as Consultant Medicine in pursuance to Government order No. 302-JK(HME) of 2022 dated 17.05.2022;

**AND WHEREAS**, Director Health Services, Kashmir vide letter No. Est-3/1-133/11841 dated 30.07.2022, informed that Dr. Maqsood Ahmad Dar has not joined in the Directorate of Health Services, Kashmir within the stipulated time period;







**AND WHEREAS,** appointment order issued vide Government order No. 302-JK(HME) of 2022 dated 17.05.2022, inter-alia, provides that in case of failure of any appointee to join within the stipulated time period of twenty one (21) days, his/her appointment shall be deemed to have been cancelled ab-initio without any further notice;

**AND WHEREAS,** Dr. Maqsood Ahmad Dar have failed to join within the stipulated period of twenty one (21) days from the date of issuance of appointment order, as such, his right to appointment is forfeited.

**NOW, THEREFORE,** the appointment of Dr. Maqsood Ahmad Dar S/o Abdul Hameed Dar R/o Bul Bul Nowgam, Anantnag as Consultant Medicine issued vide Government order No. 302-JK(HME) of 2022 dated 17.05.2022, is hereby cancelled with immediate effect.


