In terms of Rule 62(1), Rule 62(a) & Rule 73(1) of the J&K Civil Services (Leave) Rules, 1979 read with SRO 346 dated 17.10.2012 & SRO-274 dated 30.05.2013, sanction is hereby accorded to the grant of study leave in favour of Dr. Meenakshi Dingra, Medical Officer, SDH Jagti, Nagrota for undergoing DNB course in Anesthesia from Government Hospital, Gandhi Nagar, Jammu for a period of one year (out of three years) w.e.f 01-03-2022, in the first instance, subject to the following conditions:-

- i. The Doctor shall have no superior claim over her seniors for consideration for promotion after acquiring higher qualification.
- ii. That the stipend, scholarship etc., if any, received during study leave is adjusted in her leave salary;
- iii. That the doctor shall execute a bond in form 6 before the Director, Health Services, Jammu, as required under the J&K Civil Services (Leave) Rules, 1979;
- iv. That the doctor shall submit the certificate of examination of 1st year passed before the administrative department before seeking extension in study leave; and
- v. That the doctor shall comply with all other conditions as laid down in study leave rules as amended from time to time.

Besides, it is further ordered that the period of PG Course in Pathology w.e.f. 05.02.2022 to 28-02-2022 which has been pursued by the said doctor from Government Medical College, Jammu shall be treated as leave whatever kind due.
