Accordingly, it is hereby ordered that the stepping up of pay and pay scale in favour of 24 Sr. Pharmacists, mentioned in the annexure to this order, sanctioned vide Government Order No 535- HME of 2009 dated 15.12.2009 issued under endorsement No HD/65/65/2008 dated 15.12.2009 is hereby withdrawn ab-intio.


