In terms to Rule 61(1), Rule 62(a) & Rule 73(1) of the J&K Civil Service (Leave) Rules, 1979 read with SRO-346 dated 17.10.2012 & SRO-274 dated 30.05.2013, sanction is hereby accorded to the grant of study leave in favour of Dr. Gowhar Nabi Dar, Medical Officer, DH Pulwama for undergoing DNB-Emergency Medicine at SKIMS Soura, Srinagar for a period of one year w.e.f. 17.11.2022 (out of three years) in the first instance. However, this shall be subject to the following conditions:-

- ii. That he shall have no superior claim over his seniors for consideration for promotion after acquiring higher qualification;

- v. The doctor shall execute a bond in Form-6, in terms of the rule 64(3) of the Jammu and Kashmir Civil Service (Leave) Rules, 1979.
