Subject:- Sanction of Leave Travel Concession (LTC) in favor of the Medical Officers of Directorate of AYUSH, J&K.

Sanction is hereby accorded to the grant of LTC in favor of the following Medical Officers of Directorate of AYUSH, J&K to visit Goa along with family members from 30.11.2022 to 10.12.2022:

1. Dr. Vishnu Kumar Datta working as Medical Officer, Government Ayurvedic Hospital Jammu.
2. Dr. Arun Gupta working as Medical Officer, Government Ayurvedic Hospital Jammu.
3. Dr. Rajesh Gupta working as Medical Officer, AH & WC Battal Ballain Udhampur.

The sanction shall be subject to the following conditions:-

- a) An entry shall be made in the service book of the doctors as prescribed under Rule 16 (1) and 16 (2) of the J&K Civil Services (LTC) Rules, 2019;
- b) The leave during the period shall be sanctioned by the competent authority;
- c) The officers shall submit the final LTC claim on Form 3 within one month from the date of return journey after availing the LTC;



- d) The other conditions for grant of this concession shall be same as laid down in J&K Civil Services (LTC) Rules, 2019;
- e) This sanction shall be for the Block 2020-23.

Accordingly, the funds amounting to Rs. 0.87 and Rs. 0.44 lacs have been released to Director AYUSH, J&K through BEAMS under sub head 1315-Ayurvedic Hospital, Jammu and 0696-Unani Ayurvedic Dispensaries, Jammu respectively under Detailed Head – 003 - LTC.


