Whereas, Dr. Ramesh Chander Koul and Dr. Popinder Kumar Raina appointed as Medical Officer (Ayurvedic) w.e.f. 09.03.1989 are figuring at S.No. 3 and 4 respectively in the Final Seniority list of Medical Officers (Ayurvedic) of J&K Indian System of Medicines (now AYUSH) issued vide Government Order No. 323-JK(HME) of 2022 dated 27.04.2021 as it stood on 01.01.2021;

And Whereas, vide letter No. Dir-Ayush/Est/6822 dated 01.06.2022 Director Ayush, J&K has informed that Dr. Ramesh Chander Koul and Dr. Popinder Kumar Raina, Medical Officers (Ayurvedic) have shown their unwillingness for their placement as I/C District Ayush Officer (Ayurvedic) and its equivalent;

And Whereas, the matter has been examined in the department and it has been found that Dr. Ramesh Chander Koul and Dr. Popinder Kumar Raina, Medical Officers (Ayurvedic) are not interested to work as I/C District Ayush Officer (Ayurvedic) and its equivalent and this action on their part are willful & intentional;

Now, therefore, it is hereby ordered that the future claim of Dr. Ramesh Chander Koul and Dr. Popinder Kumar Raina, Medical Officers (Ayurvedic) for their placement as Incharge District Ayush Officer (Ayurvedic) and its equivalent is hereby rejected.
