**Subject:** Grant of Study Leave in favour of Tarun Singh, MTS of Government Medical College, Jammu.

In terms of Rule-73 of the J&K Civil Services (Leave) Rules, 1979 read with SRO-274 of 2013 dated 30.05.2013, as amended from time to time, sanction is hereby accorded to the grant of study leave in favour of Tarun Singh, MTS of Government Medical College, Jammu initially for a period of one year (twelve months), for pursuing Paramedical/higher studies course (OT Technician) for the session 2023-2025, from Indian Institute of Technical Training, Bari Brahmana Samba for better patient care.

The study leave, however, shall be subject to following terms and conditions:-

- i. That the official shall have no superior claim over the seniors for consideration for promotion after acquiring higher qualification.
- ii. That the official shall in no case be drafted for any duties including wait land night duties, during the study period.
- iii. That the stipend, scholarship etc, if any, received during pursuing of higher studies is adjusted in his leave salary.
- iv. That all other relevant conditions as laid down in Study Leave Rules are strictly adhered to.
- v. That on completion of course, the applicant shall submit the certificate of examination passed or special courses of study undertaken indicate the date of commencement and termination of the course to the Principal, GMC, Jammu.
- vi. That a period entry of Study Leave is made in the Service Book of the Official.
- vii. In case, the official abandoned his higher study course midway, the delinquent official shall be subject to the imposition of following penalties:
  - a) Withholding of two increments.
  - b) Imposition of a penalty amount to the tune of Rs.50,000/- (Fifty thousand) only with the recovery during the training of said course.



- c) Ban from future participation in Government sponsored educational programs or training courses for a period of 5 years.
