The study leave, however, shall be subject to following terms and conditions:-

- i. That the official shall have no superior claim over their seniors for consideration for promotion after acquiring higher qualification.
- ii. That the official shall in no case be retained the hospital for any duties including wait land night shift duties, during the study period.



- iii. That the stipend, scholarship etc, if any, received during pursuing of higher studies is adjusted in his leave salary.
- iv. That all other relevant conditions as laid down in Study Leave Rules are strictly adhered to.
- v. That on completion of course, the applicants shall submit the certificate of examination passed or special courses of study undertaken, indicated the date of commencement and termination of the course to the Principal, GMC, Jammu.
- vi. That a period entry of Study Leave is made in the Service Book of the Officials.
- vii. In case, the officials abandoned their higher study courses midway, the delinquent officials shall be subject to the imposition of following penalties:
 - a) Withholding of two increments.
 - b) Imposition of a penalty amount to the tune of Rs.50,000/-(Fifty thousand) only with the recovery during the training of said course.
 - c) Ban from future participation in Government sponsored educational programs or training courses for a period of 5 years.
