Termination of services of Dr. Mir G R Wali, Lecturer,

Department of Orthopaedics, Government Medical College

Government Order No.407-JK (HME) of 2024 Dated: 25.06.2024

WHEREAS, on the recommendation of J&K, Public Service Commission, among others, Dr. Mir G R Wali was appointed as Lecturer in the Department of Orthopaedics in Government Medical College, Srinagar vide Government Order No. 350-HME of 2018 dated 06.06.2018; and

WHEREAS, Principal, Government Medical College, Srinagar vide letter dated 25.05.2022 forwarded copy of application of Dr. Mir G R Wali, Lecturer (Orthopaedics), Government Medical College, Srinagar duly endorsed by HoD Orthopaedics wherein he submitted that he has been offered a Fellowship in Orthopedic Oncology and Joint Reconstruction at Royal National Orthopedic Hospital, London for a period of 12 months starting July, 2022. Principal, Government Medical College, Srinagar requested for grant of necessary permission in his favour; and

WHEREAS, the case was examined in the Department and, accordingly, vide this Department's letter dated 27.06.2022, Principal, Government Medical College, Srinagar was requested to furnish requisite information related to the case. In response, Principal, Government Medical College, Srinagar vide letter dated 27.07.2022 stated that the participating faculty should have five years service at his credit while as the applicant is likely to complete 05 years of service on 15.08.2023; and



WHEREAS, in the meanwhile, Principal, Government Medical College, Srinagar vide letter dated 05.08.2022 reported that Dr. Mir G R Wali, Lecturer (Orthopedics), Government Medical College, Srinagar left the station on 01.08.2022 to undergo Fellowship in Orthopedics Oncology and Joints Reconstruction at Royal National Orthopedics Hospital, London as intimated by HoD Orthopaedics, Government Medical College, Srinagar; and

WHEREAS, the case was examined in the Department in terms of J&K Civil Services (Leave) Rules and Circular No. 49-JK(GAD) of 2022 dated 07.02.2022 issued by the General Administration Department and it was found that Dr. Mir G R Wali has rendered less than five (5) years service till 01.08.2022 i.e. the date on which the doctor left the station without obtaining prior permission from the Competent Authority. Thus, Dr. Mir G R Wali is not eligible for availing study leave; and

WHEREAS, vide this Department's letter dated 20.12.2022, Principal, Government Medical College, Srinagar was requested to issue final show cause notice through Print Media (three leading dailies) as well as on the residential address of Dr. Mir G R Wali, Lecturer (Orthopedics), Government Medical College, Srinagar with a categorical direction for resumption of duties within a week's time, with the stipulation in the notice that in case he fails to join within the prescribed time, action as warranted under rules shall be initiated against him in terms of Article 128 of J&K Civil Services Regulations; and

WHEREAS, in response, Principal, Government Medical College, Srinagar stated that a Final Show Cause Notice was served to the doctor on his residential address and also published in print media with the directions to resume his duties within a week's time from the date of issuance of the show cause notice. The Principal further stated that in response to the said notice, the doctor has submitted:

(i) That he applied for one year fellowship in Orthopedic Oncology and Joint Reconstruction at Royal National Orthopedic Hospital Stanmore UK in late 2021 for a proposed start date from April 2022.

(ii) That he applied for grant of leave to pursue this fellowship duly endorsed by HoD concerned.

(iii) That he didn't get the definite answer from the Administrative Department, despite more than two months since application.

(iv) That he proceeded to join the fellowship starting 01.08.2022, as the fellowship involves both clinical and research roles, which will help to establish such a facility in Bone & Joint Hospital so that people are benefited at large.

WHEREAS, the reply submitted by Dr. Mir G R Wali was examined in the Department and it was found that he has left the station/ country, without seeking proper permission from the Competent Authority and, accordingly, on 17.07.2023, Final Show Cause Notice was served to Dr. Mir G R Wali by this Department with categorical direction to submit a written statement to explain his conduct of his unauthorized absence, and as to why his services shall not be terminated in terms of Article 128 of J&K Civil Service Regulations, 1956 within 10 days, failing which it shall be presumed that he has nothing to say in his defense and action as warranted under Article 128 of J&K Civil Service Regulations, 1956 shall be initiated against him. Besides, a copy of Show Cause Notice was forwarded to Principal, Government Medical College, Srinagar and Director Information with the request to serve the notice to the doctor through Print Media, Social Media as well as on his residential address/ permanent address; and

WHEREAS, in response, Principal, Government Medical College, Srinagar vide communication dated 08.08.2023 stated that Show Cause Notice was served to Dr. Mir G R Wali through WhatsApp, Registered Post and Speed Post on his permanent as well as residential address. However, no response from the doctor was received; and

WHEREAS, vide Government Order No. 565-JK(HME) of 2023 dated 17.07.2023, the request of Dr. Mir G R Wali, Lecturer (Orthopaedics) in Government Medical College, Srinagar for sanction of study leave for one-year Fellowship in Orthopaedic Oncology & Joint Reconstruction at Royal National Orthopaedic Hospital London, UK has been rejected by the Department; and

WHEREAS, Principal, Government Medical College, Srinagar vide letter dated 19.01.2024 informed that Dr. Mir G R Wali has



not reported back to the Department till date and his office has no information about whereabouts of the doctor; and

WHEREAS, the case was further examined in the Health & Medical Education Department in light Article 128 of the Jammu & Kashmir Civil Service Regulations and it has been found that Dr. Mir G R Wali has remained on un-authorized absence from his duties and, therefore, he has lost his service in view of the import of Article 128 of the Jammu & Kashmir Civil Service Regulations.

Now, therefore, in terms of Article 128 of the Jammu & Kashmir Civil Service Regulations, 1956 read with Rule 30 of the Jammu & Kashmir Civil Services (Classification, Control & Appeal) rules, 1956, Dr. Mir G R Wali, Lecturer in the discipline of Orthopaedics, Government Medical College, Srinagar, is, hereby, removed from Government services w.e.f. 01.08.2022 i.e. the date of his unauthorized absence from duties.
