Subject: Settlement of un-authorized period of absence in favour of Dr.Sunil Kumar Bhat , Medical Officer, DH Reasi.

Government Order No. 410 -JK(HME)of 2024

Dated: 25-06-2024

Whereas, Dr. Sunil Kumar Bhat was appointed as Medical Officer vide Government Order No. 212-HME of 2007 dated 28.03.2007 and was posted at DH Reasi;

Whereas, the doctor, while posted at DH Reasi was selected for DNB Super Specialty Course and in Genito Urinary Surgery (Urology) in Kerala and he pursued the same without prior approval of the competent authority;

Whereas, the doctor after completion of the course submitted his joining report on 23.08.2021 in DHSJ and after examination of the case in the department, vide Government Order No. 368-JK(HME) of 2022 dated 03.06.2022 among others, the doctor was allowed to re-join his duties with prospective effect subjected to the condition that the period of his un-authorized absence shall be decided separately;

Whereas, the vide Government Order No. 515-JK(HME) of 2022 dated 18.07.2022, Dr. Sunil Kumar Bhat was deputed to Urology Department, Super Speciality Hospital, GMC, Jammu for utilization of his service in Renal Transplant Programme;

Whereas, the doctor approached the department for settlement of above mentioned period and after examination, the case was placed before the Departmental Designated Committee for settlement of unauthorized absence period. The Committee examined the case meticulously in its meeting held on 22.01.2024 and recommended as under:-

"i) Since the Dr. Sunil Kumar Bhat, Medical Officer was appointed as Medical Officer in the year 2007, as such he has sufficient years of service in his credit as per rules for study leave at that point of time, but the doctor concerned left for undergoing DNB course without NOC/permission from the competent authority. Accordingly, the Committee has recommends that the period of undergoing DNB course w.e.f 28.03.2018 to 02.06.2022 in favour of Dr. Sunil Kumar Bhat, Medical Officer may be treated as " **Leave whatever kind due, except study leave and the remaining period of short fall as Dies Non**"

Besides, the concerned doctor shall be warned not to leave his place of posting for any occasion in future without sanctioning of leave from the competent authority, failing which disciplinary action, as warranted under rules, shall be initiated against him without any further notice".

Now, therefore, on the recommendations of the Departmental Designated Committee, sanction is hereby accorded to treat the period of undergoing study & awaiting w.e.f. 28.03.2018 to 05.06.2022 in favour of Dr. Sunil Kumar Bhat, Medical Officer, as " **leave whatever kind due" except study leave and remaining period of shortfall be treated as Dies Non**, subject to the condition that the said doctor was not involved in any subversive activities as well as he was not employed in any Government/Private sector and no departmental enquiry is pending against him, for which an affidavit authenticated by 1st Class Judicial Magistrate shall be obtained by the Directorate of Health Services, Jammu from the concerned doctor.

Besides, the concerned doctor shall be warned not to leave his place of posting for any occasion in future un-authorizedly, for which disciplinary action shall be initiated against him without any further notice".


