Subject: Settlement of intervening period of absence in favour of Dr. Ishtiyag Qadri, Medical Officer, PHC Khrew, Pampore.

**Government Order No. 419 -JK(HME)of 2024**  
**Dated: 27-06-2024**

**Whereas,** the Director, Health Services, Kashmir vide letter No. Est/3/1-133/5684 dated 21-11-2023 forwarded the application of Dr. Ishtiyag Qadri, Medical Officer for settlement of intervening period w.e.f 01.05.2023 to 15.10.2023. The concerned doctor while posted at PHC Khrew, Pampore was transferred to NTPHC- Tantana, Doda vide Government order No.367-JK(HME) of 2023 dated 29.04.2023;

**Whereas,** the doctor aggrieved by the said transfer order approached the Hon'ble Central Administrative Tribunal, Srinagar through A.O No. 389/2023 on the plea that he has a dependency of a disabled child. The Hon'ble CAT passed following order dated 18.05.2023 , the operative part of which reads as under;

*"In view of the limited prayer made by the Learned Counsel for the applicant, the respondents are directed to consider the representation of the applicant dated 01.05.2023, especially in accordance with two Office Memorandums dated 06.06.2014 and 17.11.2014, within a period of two weeks from today. Till final decision is taken in the representation, the applicant shall not be relieved from his present place of posting."*

**Whereas,** after examination of the case in the department, vide Government order No.847-JK(HME) of 2023 dated 16.10.2023, the concerned doctor was retained at his previous place of posting i.e PHC Khrew, Pampore, Pulwama;

**Whereas,** the case regarding settlement of intervening period w.e.f. 01.05.2023 to 15.10.2023 in favour of Dr. Ishtiyaq Qadri, Medical Officer was placed before the Departmental Designated Committee and which met on 22.01.2024 under the chairmanship of Director Finance, Health & Medical Education Department. The Committee deliberated upon the case meticulously and recommended as under:

***"May treat the intervening period w.e.f 01.05.2023 to 15.10 .2023 as "leave whatever kind due to him."***

**Now, therefore,** on the recommendations of the Departmental Designated Committee and after due approval, sanction is hereby accorded to treatment of intervening period of Dr.Ishtiyaq Qadri, Medical Officer **w.e.f. 01.05.2023 to 15.10.2023 as "leave whatever kind due to him.**


