Engagement of faculty in various disciplines on academic arrangement

basis in Government Medical College, Baramulla.

Government Order No. 443-JK (HME) of 2024 Dated: 06.07.2024

As recommended by the Selection Committee, sanction is hereby accorded to the engagement of following candidates against the posts of Assistant Professor in the disciplines indicated against each in Government Medical College, Baramulla on academic arrangement basis in terms of the Jammu & Kashmir Medical & Dental Education (Appointment on Academic Arrangement Basis) Rules, 2020 notified vide S.O 364 of 2020 dated 27.11.2020:

The engagement of the candidates shall be subject to following conditions:

- 1. The candidates shall report to Principal, Government Medical College, Baramulla for joining within a period of twenty one (21) days, from the date of issuance of this order, failing which their engagement as such shall stand cancelled without any further notice.
- 2. The arrangements shall be purely on temporary basis and shall not confer upon the engagees any special claim/right for their appointment against the said posts on regular basis as and when the same are filled under rules.
- 3. The candidates shall have to execute an agreement with the Government on the prescribed Form in terms of S.O 364 of 2020 dated 27.11.2020. The engagement shall be for a period of one year or till the posts are filled-up on regular basis on the recommendations of Jammu and Kashmir, Public Service Commission, whichever is earlier.



- 4. The above engagements of shall be regulated under other terms and conditions as specified in S.O 364 2020 dated 27.11.2020. The engagements so made on academic arrangement basis shall be extendable upto maximum of six years (one year at a time and subject to good performance and conduct) or till selections are made in accordance with the rules of recruitment governing the posts, whichever is earlier, and the extension so granted under these rules shall not be beyond a period of six years under any circumstances.
- 5. The consolidated salary in their favour shall be released only after the verification of their character and antecedents from the Criminal Investigation Department.
