WHEREAS, on the recommendations of J&K Public Service Commission, vide Government Order No. 559-HME of 2018 dated 05.10.2018, Dr. Mohd Zubair Qureshi was appointed as Lecturer (Blood Bank) in Government Medical College, Srinagar and subsequently promoted as Assistant Professor (Blood Bank) vide Government Order No. 485-JK(HME) of 2023 dated 09.06.2023; and

**WHEREAS,** on 15.04.2023, Dr. Mohd Zubair Qureshi submitted his resignation before Principal, Government Medical College, Srinagar citing reasons of his fresh appointment as Assistant Professor in the Department of Blood Transfusion & Immunohematology in SKIMS Soura Srinagar; and

**WHEREAS,** Principal Government Medical College, Srinagar vide letter dated 27.09.2023 forwarded the application of the said Lecturer for acceptance of his resignation; and

WHEREAS, the matter was examined in the Health & Medical Education Department and vide this Department's letter dated 17.10.2023, Principal, Government Medical College, Srinagar was requested to furnish certain documents/information related to the case; and

WHEREAS, in response, Principal Government Medical College Srinagar vide letter dated 18.10.2023 furnished requisite information/documents related to the case and requested for acceptance of resignation of faculty member from the post of Assistant Professor

AND WHEREAS, the case was further examined in the Department in terms of Article 200 of the Jammu & Kashmir Civil Service Regulations, 1956 and it was decided to accept the resignation of Dr. Mohd Zubair Qureshi from the post of Assistant Professor (Blood Bank) in Government Medical College, Srinagar w.e.f 15.04.2023, on his own request;

**Now, therefore,** in exercise of the powers conferred under Article 200 of the Jammu & Kashmir Civil Services (Classification, Control and Appeal) Rules, 1956, the resignation of Dr. Mohd Zubair Qureshi from the post of Assistant Professor (Blood Bank) in Government Medical College, Srinagar appointed vide Government Order No. 559-HME of 2018 dated 05.10.2018, is accepted on his own request and is discharged from services of Government Medical College, Srinagar w.e.f 15.04.2023.
