Subject: Settlement of period of study in favour of Dr. Hardeep Kumar,
B-Grade Physician, Sagar Suri Hospital, Sanjichat, Katra.

Whereas, Dr. Hardeep Kumar, was appointed as B-Grade Physician vide Government Order No. 596-HME of 2009 dated 31.12.2009 and was posted in Sagar Suri Hospital, Sanjichat, Katra;

Whereas, vide communication No. Est/3/5493/2581 dated 08.12.2011, Director Health Services, Kashmir forwarded an application of doctor, stating that he got selected for DM Neurology course (03 years), commencing on January 2012 at Sri Chitra Tirunal Institute of Medical Sciences and Technology, Trivandrum, Kerala;

Whereas, the doctor after completion of the said course got selected for fellowship in Epilepsy for a period of one year. After the completion of said fellowship, the concerned doctor submitted his joining report in Directorate of Health Services, Jammu on 12.01.2016 and his case for joining was forwarded to the Administrative Department by the Director Health Services, Jammu;

Whereas, the case of the doctor was examined in the department and vide this departments letter No. HD(Gaz)Gen/54/2016 dated 27.04.2016 approval of the Administrative Department was conveyed to allow Dr. Hardeep Kumar, Consultant Medicine to join the department;

Whereas, the doctor awaiting orders of adjustment, was posted in Government Hospital Gandhi Nagar Jammu vide DHSJ order No. 446-G of 2016 dated 13.06.2016 keeping in view his Super Specialization of the subject;

Whereas, vide Government Order No. 521-HME of 2016 dated 23.09.2016, Dr. Hardeep Kumar (DM Neurology) Consultant Physician was transferred from Government Hospital Gandhi Nagar and posted in the Department of Neurology, GMC, Jammu on deputation basis;

Whereas, Director Health Services, Jammu and Principal, Government Medical College Jammu respectively forwarded his case regarding settlement of study leave period w.e.f. 01.01.2012 to 31.12.2014 (DM Neurology) & 01.01.2015 to 11.01.2016 (Fellowship) in favour of Dr. Hardeep Kumar, Consultant Physician;

Whereas, after examination, the case was placed before the Departmental Designated Committee in its meeting held on 02.02.2023 under the chairmanship of Director Finance, Health & Medical Education Department. The Committee deliberated upon the case meticulously and recommended as under:

*"i) to treat the period for undergoing DM (Neurology) course w.e.f. 01.01.2012 to 31.12.2014 (DM Neurology & 01.01.2015 to 11.01.2016 (Fellowship) in favour of Dr. Hardeep Kumar, Consultant Physician as **leave whatever kind due including extra ordinary leave without allowances (except study leave)**, subject to the condition that the said doctor was not involved in any subversive activities and was not employed in any Government/Private sector and no departmental enquiry is pending against him, for which an affidavit authenticated by 1st Class Judicial Magistrate shall be obtained by the Directorate of Health Services, Jammu from the concerned doctor.*

Besides, the concerned doctor is warned not to leave his place of posting for any occasion in future un-authorized, for which disciplinary action shall be initiated against him without any further notice".

NOW, THEREFORE, on the recommendations of the Departmental Designated Committee, sanction is, hereby, accorded to treat the period of undergoing DM (Neurology) **w.e.f. 01.01.2012 to 31.12.2014** and **01.01.2015 to 11.01.2016** (Fellowship) in favour of Dr. Hardeep Kumar, Consultant Physician as **Leave whatever kind due including Extra Ordinary Leave without allowances (except Study Leave)** subject to the condition that the said doctor was not involved in any subversive



activities as well as he was not employed in any Government/Private sector and no departmental enquiry is pending against her, for which an affidavit duly authenticated by 1st Class Judicial Magistrate shall be obtained by the Directorate of Health Services, Jammu from the concerned doctor.

Besides, the concerned doctor shall be warned not to leave his place of posting for any occasion whatsoever in future without proper permission from the Competent authority, for which disciplinary action, as warranted under rules, shall be initiated against him without any further notice.
