On the basis of recommendation of the J&K Service Selection Board vide communication No. JKSSB/55/2022-05 (7048574) dated 19.03.2024 duly forwarded by the General Administration Department vide OM GAD/MTG/RBIV/01/2023 (E-7098912) dated 16.04.2024 and in continuation of Government Order No. 769–JK(HME) of 2022 dated 29.10.2022 read with Government Order No. 212-JK(HME) of 2024 dated 15.03.2024 on the subject, sanction is hereby accorded to the temporary appointment of below mentioned candidate (in respect of whom CID report has been received from the concerned agency), as Class-IV in the Pay Level SL-I (14800-47100) in the organization of the Health & Medical Education Department, as per the details indicated below:-

The appointment of the aforesaid candidate shall be subject to the following conditions:-

A. The appointee shall submit her joining report physically to the concerned HOD of the Organization indicated against her within a period of 21 days from the date of issuance of this order and in case of failure of appointee to join within the stipulated period; her appointment shall be deemed to have been cancelled ab-initio without any further notice.

B. The appointee shall be allowed to join by the concerned Head of Department (HOD) only on production of the following certificates in original:-

- i. Academic Qualification Certificates.
- ii. Matriculation/Date of Birth Certificate.
- iii. Health Certificate issued by the Chief Medical Officer.

- iv. *Domicile Certificate issued by the Competent Authority.*
- v. *That if the candidate has taken loan for self-employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment and Counseling Centre of the domicile District, he/she shall relinquish the proprietorship of unit /enterprise and also stakes, if any, in such self employment Unit / enterprise before joining the Government Service. He/she shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his/her salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self-employment unit/enterprise and recovery to be made and also personally monitor its recovery*
- vi. *Relevant category certificate(s), (in case of candidates belonging to reserved categories).*
- vii. *Any other certificates/documents as required under rules/norms.*

C. The appointee shall give an undertaking duly attested by the First Class Judicial Magistrate in the shape of an affidavit to the effect that:-

- i. *if on verification from the concerned issuing authorities, the qualification certificate/reserved category certificate/experience certificate (wherever applicable) is found forged, false or fake, the appointee shall have no claim for appointment.*
- ii. *salary of the appointee shall not be drawn and disbursed to him/her unless and until the satisfactory report/ genuineness of the certificates in respect of Condition C (i) is received.*
- iii. *The appointment of the candidates shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 dated 24.12.2009.*
- iv. *appointee shall abide by all the terms & conditions as laid down in this appointment order.*
- v. *appointee have no criminal records and also is not facing any criminal proceedings in any Court of Law.*
- vi. *appointee shall be liable for action as warranted under rules for violating any of the laid down conditions as indicated in the appointment order.*

D. The inter-se-seniority of the appointee shall be drawn in accordance with the merit secured by the appointee in the selection list prepared by the J&K Services Selection Board.

E. The appointee shall be on probation for a period of two (02) Years.

F. The appointment of the candidate shall be subject to outcome of the writ petition (s), if any, pending before any Competent Court/Tribunal etc.

G. The cadre/Department allocated by the J&K Services Selection Board/ appointing authority shall not be changed under any circumstances by any authority/Department.

H. The appointment shall be cancelled ab-initio, if it is found that the candidate is having higher qualification than the prescribed one at any stage later on and he/she shall also be liable for criminal prosecution.
