- ii. He shall retain his lien/promotion prospects in his own parent department.
- iii. He shall have no superior claim over his seniors for consideration of promotion after acquiring such higher qualification(s).
- iv. In case, the concerned doctor fails to rejoin back in his parent department immediately after completion of such tenure posting/training course, disciplinary proceedings shall be initiated against him without any further notice
