It is, hereby, ordered that the details/particulars of the following doctors shall and shall always be deemed to have been deleted ab-initio from the purview of Government Order No. 352 - JK(HME) of 2023 dated 26.04.2023 issued by Health & Medical Education Department:-

1. Dr. Usman Anwar, Medical Officer (S.No. 02)
2. Dr. Iram Anwar, Medical Officer (S.No. 04)

It is further ordered that:

- i. The Director, Health Services, Jammu shall explain as to why the names of the aforesaid two doctors have been recommended to the Administrative Department for recalling from GMC Jammu while as they are unauthorizedly absent. The Directorate of Health Services, Jammu shall initiate disciplinary proceedings against these two doctors immediately as warranted under rules for remaining unauthorizedly absent from duties and furnish the consolidated proposal after fulfillment of all codal formalities to the Administrative Department for termination of their services.
- ii. The Principal GMC, Jammu shall explain as to why the issue regarding unauthorized absence of aforesaid two doctors was not brought immediately to the notice of Directorate of Health Services, Jammu/ Administrative Department for initiating further course of action against these doctors.
