Subject: Engagement of faculty in Government Medical College, Rajouri under S.O 364 of 2020 dated 27.11.2020.

As recommended by the Selection Committee, sanction is, hereby, accorded to the engagement of following candidates against the post(s) and in the discipline(s) indicated against each in Government Medical College, Rajouri, on academic arrangement basis, in terms of the Jammu and Kashmir Medical and Dental Education (Appointment on Academic Arrangement Basis) Rules, 2020, notified vide S.O 364 of 2020 dated 27.11.2020:-

The engagement of the candidates against the faculty posts is subject to following conditions:

1. The candidates shall report to Principal, Government Medical College, Rajouri for joining within a period of twenty-one (21) days, from the date of issuance of this order, failing which their engagement as such shall stand cancelled without any further notice.
2. The arrangements shall be purely on temporary basis and shall not confer upon the candidates any special claim/ right for their appointment against the said posts on regular basis as and when the same are filled under rules.
3. The candidates shall have to execute an agreement with the Government on the prescribed Form in terms of S.O 364 of 2020 dated 27.11.2020. The engagement shall be for a period of one year

or till the posts are filled-up on regular basis on the recommendations of Jammu and Kashmir, Public Service Commission, whichever is earlier.

4. The above engagements shall be regulated under other terms and conditions as specified in S.O 364 dated 27.11.2020. The engagements so made on academic arrangement basis shall be extendable upto maximum of six years (one year at a time and subject to good performance and conduct) or till selections/promotions are made in accordance with the rules of recruitment governing the posts, whichever is earlier, and the extension so granted under these rules shall not be beyond a period of six years under any circumstances.
5. The salary in favour of the engaged faculty shall not be released unless satisfactory reports are received from the Criminal Investigation Department, J&K.
