Subject:- Acceptance of Technical resignation in favour of Dr. Gagandeep Kour, Medical Officer, Government Ayush Dispensary Lowang, District Kathua.

WHEREAS, Dr Gagandeep Kour, Medical Officer, Government Ayush Dispensary Lowang, District Kathua approached the department through the medium of representation whereunder she sought permission for appearing in UPPSC Medical Officer interview, held on 05.12.2022;

AND WHEREAS, the department vide letter dated 30.01.2023 conveyed *postfacto* sanction in favour of Dr Gagandeep Kour Medical Officer, Government Ayush Dispensary Lowang, District Kathua for appearing in the UPPSC Medical officer, conducted by the Uttar Pradesh Public Service Commission;

AND WHEREAS, the aforesaid officer again the approached the on 01.02.2023 with the submission that she has been provisionally selected by the UPPSC of Uttar Pradesh as Medical officer, and the said commission is seeking No Objection Certificate from the department, before her joining;

AND WHEREAS, the case was examined in the department and it was recommended that the officer has been selected as Medical officer by the UPPSC Uttar Pradesh and is desirous to join there, and the officer can not be deprived to exercise her choice of employment;

AND WHEREAS, the department vide letter dated 21.02.2023 conveyed No Objection Certificate of Health and Medical Education Department, J&K to Secretary Public Service Commission Uttar Pradesh with the condition that she may be allowed to join as Medical Officer, in the said commission only after the acceptance of the resignation by this department to be tendered by the officer through the concerned Head of the Department;

AND WHEREAS, Dr Gagandeep Kour Medical Officer, Government Ayush Dispensary Lowang, District Kathua has now forwarded her case through Directorate of Ayush J&K, for acceptance of technical resignation in her favour w.e.f 11.08.2023.

AND WHEREAS, Article 201 of J&K CSR Vol-1 envisages as under:-
“...201. Resignation of an appointment to take up another appointment in which service counts, is not to be held to be a resignation of the Government service, provided the consent of the former departmental superior is obtained to accepting, such employment.”

Now, therefore, in terms of Article 201 of J&K CSR Vol-1, the technical resignation tendered by Dr Gagandeep Kour Medical Officer, Government Ayush Dispensary Lowang, District Kathua from the J&K Ayush (Gazetted) Service is, hereby, accepted w.e.f 11.08.2023, on her own request/responsibility and her lien in the J&K Ayush (Gazetted) Service shall be deemed to have been terminated forthwith.


