In continuation to Government Order No. 404-JK(HME) of 2023 dated 15-05-2023 and Government Order No. 721-JK(HME) of 2023 dated 04-09-2023, sanction is hereby, accorded to release and advance drawl of ₹ 208.62 Lakhs (Rupees Two Crore Eight lakh and Sixty Two thousand) only under Capex Budget 2023-24 as Matching UT Share under Centrally Sponsored Scheme "National AYUSH Mission" and its placement at the disposal of Director Ayush, J&K for utilization of the funds during the current financial year (2023-24) towards the approved components of the scheme. The sanction to the release and advance drawl of funds shall be, however, subject to the following conditions:

1. that Director Finance, Health & Medical Education Department shall vouchsafe the availability of funds on BEAMS portal and accordingly release the funds to the concerned.
2. that the expenditure shall be booked on admissible items only as approved by the competent authority.
3. that all the codal formalities as per GFR 2017 shall be followed at all levels with due diligence while incurring expenditure out of the funds already authorized.
4. that the funds so released shall be utilized for the purpose meant for without any deviation/diversion.
5. that the UCs/Red Accounts Details of advance drawl shall be furnished to the concerned quarters within the stipulated time.
6. that Director Ayush, J&K shall furnish the physical and the financial progress report of the scheme every month to this Department, which shall be open to, on spot verification.
7. that Treasury Officers shall not entertain bills without ascertaining complete classification under which funds have been authorized by the Finance Department.

8. that Treasury Officer shall not allow parking or drawl of funds in the Civil Deposit without prior concurrence of the Finance Department.
9. that the funds shall not be parked un-necessarily.
10. that all conditions contained in BEAMS release order shall be adhered to.
