In terms to Rule 61(1), Rule 62(a) & Rule 73(1) of the J&K Civil Service (Leave) Rules, 1979 read with SRO-346 dated 17.10.2012 & SRO-274 dated 30.05.2013, sanction is, hereby, accorded to the grant of study leave in favour of Dr. Omer-Bin-Hassan, Medical Officer, Block Charar-I-Sharief, Budgam for undergoing Post MBBS Diploma (Chest Medicine) at Government Medical College, Anantnag for a period of one year (out of two years) w.e.f. 03.10.2023 in the first instance, subject to the following conditions:-

- i. The work load on account of his study leave is managed through internal arrangement;
- ii. That the doctor shall have no superior claim over his seniors for consideration for promotion after acquiring higher qualification;
- iii. The course undertaken is purely in public interest and shall prove beneficial to the Department;
- iv. The doctor shall submit the certificate of examination of 1st year passed before the Administrative Department prior to seeking extension in study leave;
- v. That the stipend, scholarship etc., if any, received by the doctor during study leave is adjusted in his salary and;
- vi. The doctor shall execute a bond in Form-6, in terms of the Rule 64(3) of the Jammu and Kashmir Civil Service (Leave) Rules, 1979.
