Advance drawl of Rs. 115.09460 Lakhs (Rupees One Crore Fifteen Lakh Nine Thousand Four Hundred Sixty) only as detailed above, by Director Finance, Health & Medical Education Department for crediting the funds into the Single Nodal Agency (SNA) Account of National Mental Health Programme Scheme for its onward placement with Principal, Sher-e-Kashmir Institute of Medical Sciences (SKIMS) Medical College-Hospital, Bemina Srinagar for utilization towards the approved components of the scheme during the current financial year 2023-24.

The release of funds shall be, however, subject to the following conditions:

- a. The expenditure shall be made strictly, according to the classification under which funds have been authorized by the Finance Department.
- b. Treasury Officers shall not entertain bills without complete classification under which funds have been authorized by the Finance Department.
- c. Drawing and Disbursing Officer (DDO) shall complete all codal formalities before presentation of bills at the Treasury.
- d. Treasury Officer shall not allow parking or drawl of funds in the Civil Deposit without prior concurrence of the Finance Department.
- e. The Principal, Sher-e-Kashmir Institute of Medical Sciences (SKIMS) Medical College-Hospital, Bemina Srinagar send status report about the scheme in terms of physical and financial progress made during the current financial year.
- f. The Principal, Sher-e-Kashmir Institute of Medical Sciences (SKIMS) Medical College-Hospital, Bemina Srinagar shall send Utilization Certificate (UC) of the funds as early as possible and positively before 31-03-2024 to Govt. of India under intimation to this department.
- g. All the sanctions/ approvals and clearances shall be in place before drawl of money from the treasury.



- h. Director Finance, Health & Medical Education Department shall vouchsafe the availability of funds on BEAMS portal and accordingly release / credit the funds to the concerned.
- The expenditure shall be incurred strictly as per the guidelines of the scheme and the conditions laid down in the sanction letter of the concerned ministry of Government of
- The funds shall not be available for re-appropriation/ diversion at any level.
- k. The funds need to be mandatorily credited into the SNA account of the scheme in view of the instructions that all the expenditure under CSS is to be incurred from the SNA account only as PFMS will not accept treasury data on Non-SNA releases with effect from 01/12/2022.
