**Subject:** Settlement of intervening period of absence in favour of Dr. Sonam Chalotra, Medical Officer, CHC Ramgarh.

**Government Order No. 1018 – JK (HME) of 2023**

**Dated: 08 -12-2023**

**AND WHEREAS,** Director, Health Services, Jammu vide letter No. ES-3/1411 dated 23.05.2023 has intimated that Dr. Sonam Chalotra was appointed as Medical Officer vide Government Order No. 132-HME of 2014 dated 04.03.2014;

**AND WHEREAS,** at the time of her appointment, the doctor was pursuing MD Pediatrics in Government Medical College, Jammu and after completion of her MD Course, she submitted her joining report in Directorate of Health Services, Jammu on 12.06.2017 and subsequently, Director, Health Services, Jammu posted her at DH Kathua, vide Order No. 586-G of 2017 dated 29.06.2017;

**AND WHEREAS,** while posted at DH Kathua, the doctor proceeded for undergoing Senior Residency at Lok Nayak Hospital, New Delhi at her own;

**AND WHEREAS,** the doctor, after completion of the said course, joined the Department on 07.07.2018 as she was allowed to rejoin the department by the then Medical Superintendent, District Hospital, Kathua, pending instructions from the Administrative Department;

**AND WHEREAS,** the matter was placed before the Departmental Designated Committee constituted for settlement of unauthorized absence period of the officers/officials of Health Department in its meeting held on 03.08.2023 under the chairmanship of Director Finance, Health & Medical Education Department, who examined the case threadbarely and recommended as under:-

***"(a) To treat the period of unauthorized absence of the doctor spent on undergoing Senior Residency at Lok Nayak Hospital, New Delhi w.e.f. 29.06.2017 to 06.07.2018 as "Dies-non" which shall be subject to the condition that the said doctor was not involved in any subversive activities as well as she was not employed in any Govt/Private sector and no departmental enquiry is pending against her, for***

***which an affidavit duly authenticated by 1st class Judicial Magistrate shall be obtained by the Directorate of Health Services, Jammu from the concerned doctor.***

***Besides, the doctor shall be warned not to leave her place of posting on unauthorized basis in future for which departmental actions shall be initiated against her without any notice".***

**NOW, THEREFORE,** on the recommendation of the Departmental Designated Committee, sanction is hereby accorded to treat the period spent by Dr. Sonam Chalotra, Medical Officer on underwent Senior Residency at Lok Nayak Hospital, New Delhi w.e.f. 29.06.2017 to 06.07.2018 as "**Dies-Non**", subject to the conditions that the said doctor was not involved in any subversive activities as well as she was not employed in any Govt/Private sector and no departmental enquiry is pending against her, for which an affidavit duly authenticated by 1st class Judicial Magistrate shall be obtained by the Directorate of Health Services, Jammu from the concerned doctor.

Besides, the doctor shall be warned not to leave her place of posting on unauthorized basis, in future, for which, departmental actions shall be initiated against her without any notice.
