The funds shall be utilized by CEO, SHA, AB PMJAY, J&K, subject to the following conditions:

1. That the Chief Executive Officer and Accounts Officer, Ayushman Bharat (PMJAY), J&K shall vouchsafe the availability of funds. The expenditure shall be booked on admissible items only as approved by the competent authority.
2. All codal formalities as per GFR 2017 shall be followed while incurring expenditure out of the funds already authorized.
3. The funds shall be utilized for the specific purpose only without any deviation.
4. UCs / Red Accounts of the advance drawl shall be furnished to the concerned quarters within stipulated time.

Further, State Health Agency and the concerned HoDs of Health and Medical Education Department shall ensure that:-

1. The avenues for anomalies and the dual funding for activities, consumables, drugs and services under SEHAT scheme and Revenue Budget are minimized;
2. The institution-wise analysis of expenditure on drugs, consumables & equipments from Sehat Claim Funding and Budgetary funding by empanelled Govt hospitals for 2018-2023 is submitted by 20-12-2023.
3. The reasons for non-utilization of JKMSCL services for procurement of drugs, consumables & equipments under Sehat Claim Funding are analyzed.
- 4. The practice of incentivizing the medical staff is stopped.**
5. The empanellment of private hospitals is based on transparent mechanisms and without any conflict of interest.
6. The performance of private hospitals is scrutinized to ensure professional discipline and avoid bogus or inflated claims.


