Subject:- Grant of Study leave in favour of Dr. Bilal Ahmad Lone, Medical Officer.

In terms to Rule 61(1), Rule 62(a) & Rule 73(1) of the J&K Civil Service (Leave) Rules, 1979 read with SRO-346 dated 17.10.2012 & SRO-274 dated 30.05.2013, sanction is, hereby, accorded to the grant of study leave in favour of Dr. Bilal Ahmad Lone, Medical Officer, Government Medical College, Anantnag for undergoing Post Diploma (Orthopaedics) in JLNH Hospital, Srinagar **for a period of one year** (out of two years) in the first instance.

However, this shall be subject to the following conditions:-

- i. The work load on account of his study leave is managed through internal arrangement;
- ii. That the doctor shall have no superior claim over his seniors for consideration for promotion after acquiring higher qualification;
- iii. The course undertaken is purely in public interest and shall prove beneficial to the Department;
- iv. The doctor shall submit the certificate of examination of 1st year passed before the Administrative Department prior to seeking extension in study leave;
- v. That the stipend, scholarship etc., if any, received by the doctor during study leave is adjusted in his salary and;
- vi. The doctor shall execute a bond in Form-6, in terms of the Rule 64(3) of the Jammu and Kashmir Civil Service (Leave) Rules, 1979.

Besides, the Director, Health Services, Kashmir shall ensure that the clinical works during the period of study leave of the doctor may not suffer under any circumstances.


