Subject: Settlement of authorized/unauthorized absence period in respect of Dr. Wasim Abdullah Lone, Medical Officer.

Government Order No. 235-JK(HME) of 2024
Dated: 25.03.2024

WHEREAS, Dr. Wasim Abdullah Lone was appointed as Medical Officer vide Government Order No. 212-HME of 2007 dated 28.03.2007, however, during the period he was undergoing PG in the department of Surgery at ASCOMS, Jammu;

AND WHEREAS, after completion of PG period joined back in DHSK on 13.06.2009 and was ordered to report District Hospital, Budgam vide office order dated 27.06.2009;

AND WHEREAS, the concerned doctor while posted at DH Baramulla applied for one month's earned leave w.e.f 07.10.2016 and left the station without prior permission/sanction from the authority;

AND WHEREAS, Director Health Services Kashmir issued Notice vide No. Est/3/1-133/1182-85 dated 29.06.2017, wherein, an opportunity was given to the doctor to report back for duties at District Hospital Baramulla within five days;

AND WHEREAS, the doctor failed to report back to his duties and an application was received in the Department through post on

10.07.2017, wherein, the doctor stated that he shall join back his place of posting within next two months; and

AND WHEREAS, the joining of the doctor was accepted on 26.09.2017 in the Directorate of Health Services, Kashmir after furnishing affidavit declaring therein that he will never resort to unauthorized absence in future without the approval of the Administrative Department; and

AND WHEREAS, the case was placed before the *Departmental Designated Committee* in its meeting held on **15.06.2023** who deliberated upon the case and recommended as under:-

To treat the period of unauthorized absence w.e.f. 07.10.2016 to 25.09.2017 in favour of Dr. Wasim Abdullah Lone as "Dies Non" and also shall be subject to the condition that the said doctor was not involved in any subversive activities as well as he was not employed in any government/private sector and no departmental enquiry is pending against him, for which an affidavit duly authenticated by 1st class Judicial Magistrate shall be obtained by the DHSK from the concerned doctor.

Besides, the concerned doctor shall be warned not to leave his place of posting at any occasion in future unauthorizedly, for which disciplinary action shall be initiated against him without any further notice.

NOW, THEREFORE, on the recommendations of *Departmental Designated Committee*, sanction is hereby accorded "to treat the period of unauthorized absence w.e.f. 07.10.2016 to 25.09.2017 as "**Dies-Non**" in favour of **Dr. Wasim Abdullah Lone**, Medical Officer subject to the condition that the said doctor was not involved in any subversive activities as well as he was not employed in any Government/Private sector and no departmental enquiry is pending against him, for which

an affidavit authenticated by 1st Class Judicial Magistrate shall be obtained by the Directorate of Health Services, Kashmir from the concerned doctor. Besides, the concerned doctor shall be warned not to leave his place of posting for any occasion in future un-authorizedly, for which disciplinary action shall be initiated against him without any further notice".
