- 6. The funds so released shall be utilized for the specific purpose meant for
- 7. All the required codal formalities as per GFR-2017 shall be followed at all levels with due diligence while incurring expenditure out of the funds already
- 8. Director Finance, Health & Medical Education Department shall vouchsafe the availability of funds on BAEAMS portal and accordingly release the same to the
- 9. The UCs/ Red Accounts of the advance drawl shall be furnished to the concerned quarters within the stipulated time.
