WHEREAS, Dr. Atif Naeem Raja was appointed as Medical Officer in the J&K Health Services Department vide Government Order No. 132-HME of 2014 dated 04.03.2014;

WHEREAS, Dr. Atif Naeem Raja Medical Officer was posted in Government Medical College, Srinagar on intercadre deputation vide Government Order No. 302-HME of 2014 dated 13.06.2014;

WHEREAS, the aforesaid doctor, while posted at SDH Kangan, was selected for M.ch in at SKIMS Soura;

WHEREAS, vide letter No. HD/Gaz/Gen/149/2017 dated 13.12.2017, NOC was conveyed to Director Health Services Kashmir, to relieve the doctor w.e.f. 14.09.2017 to undergo M.ch in Pediatric Surgery at SKIMS Soura, subject to the condition that the period of study shall be decided separately under SRO-274 of 2013;

WHEREAS, the doctor after completion of M.ch course joined in Director Health Services Kashmir on **14.09.2020** and was posted at Government Medical College, Anantnag vide Government Order No. 791-JK(HME) of 2020 dated 10.10.2020;

WHEREAS, the intervening period w.e.f. 14.09.2017 to 13.09.2020 of Dr. Atif Naeem Raja Medical Officer spent for M.ch Pediatric Surgery in SKIMS Soura was examined in Health and Medical Education Department in terms of relevant rules and the case was placed before the Departmental Designated Committee in its meeting held on 02.02.2023 which deliberated upon the case and recommended as under:-

NOW, THEREFORE, on the recommendations of Department Designated Committee, and after approval of the Competent Authority, sanction is hereby accorded to treat the period of undergoing MCH in Pediatrics Surgery at SKIMS, Soura w.e.f. 14.09.2017 to 13.09.2020 in favour of Dr. Atif Naeem Raja, Medical Officer as 'leave whatever kind due except study leave and remaining period shall be treated as Dies-Non' subject to the condition that the said doctor was not involved in any subversive activities as well as he was not employed in any Government/Private sector and no departmental enquiry is pending against him, for which an affidavit authenticated by 1st Class Judicial Magistrate shall be obtained by the Directorate of Health Services, Kashmir from the concerned doctor.
