Subject:- Grant of Study leave in favour of Dr. Nisar Ahmad Bhat, I/C Consultant Pediatrics, SDH Langate, Kupwara.

In terms to Rule 61(1), Rule 62(a) & Rule 73(1) of the J&K Civil Service (Leave) Rules, 1979 read with SRO-346 dated 17.10.2012 & SRO-274 dated 30.05.2013, sanction is, hereby, accorded to the grant of study leave in favour of Dr. Nisar Ahmad Bhat, I/C Consultant Pediatrics, SDH Langate, Kupwara for undergoing Post MBBS DNB (Forensic Medicine) in Government Medical College, Srinagar for a period of one year (out of three years) in the first instance, from the date of commencement of the course.

However, this shall be subject to the following conditions:-

- i. The work load on account of his study leave is managed through internal arrangement;
- ii. That the doctor shall have no superior claim over his seniors for consideration for promotion after acquiring higher qualification;
- iii. The course undertaken is purely in public interest and shall prove beneficial to the Department;
- iv. The doctor shall submit the certificate of examination of 1st year passed before the Administrative Department prior to seeking extension in study leave;
- v. That the stipend, scholarship etc., if any, received by the doctor during study leave is adjusted in his salary and;
- vi. The doctor shall execute a bond in Form-6, in terms of the Rule 64(3) of the Jammu and Kashmir Civil Service (Leave) Rules, 1979.
- vii. In case the said doctor abandons his study leave midway, he shall be subject to the following penalties:-
 - a. withholding of two increments.
 - b. Imposition of penalty to the tune of Rs. 2.0 lacs alongwith recovery of total amount paid to the delinquent doctor during the training of said course.
 - c. Ban from future participation in Government-sponsored educational programs or training courses for a period of 5 years.


