**Subject:** Settlement of authorized/unauthorized absence period in favour of Dr. Bhushan Lal Gigoo, the then Medical Officer (now Consultant Anaesthesia).

**Government Order No. 44 – JK (HME) of 2024**  
**Dated: 23 .01.2024**

**WHEREAS**, Dr. Bhushan Lal Gigoo, was appointed as Medical Officer in the Health Services Department vide Government Order No. 710-HME of 1997 dated 12.08.1997 and submitted his joining report in the Directorate of Health Services, Jammu on 01.09.1997;

**AND WHEREAS**, vide letter No. ES-3/Unth/4052 dated 15.01.2015, Director, Health Services, Jammu submitted that Dr. B.L. Gigoo, Medical Officer was on unauthorized absence w.e.f. 10.02.2014, from Sub District Hospital, Bhandarwah;

**AND WHEREAS**, vide Notice issued under endorsement No. HME/HRM/33/2015 dated 14.05.2015, among others, an opportunity was given to Dr. B.L. Gigoo, Medical Officer to report back in the Directorate of Health Services Jammu within 15 days, failing which, it shall be presumed that the concerned doctors had nothing to say in their defense and disciplinary proceedings under Article 128 of J&K CSR, Vol-I, shall be initiated against them;

**AND WHEREAS**, in response to the said Notice, Dr. Bhushan Lal Gigoo, Medical Officer submitted his rejoining in the Directorate of Health Services, Jammu on 25.05.2015 and, subsequently, vide Order No. 421-G of 2015 dated 01.08.2015, the said doctor was posted in District Hospital, Samba;

**AND WHEREAS,** later on, the concerned doctor was promoted as I/C Consultant Anaesthesia vide Government Order No. 145-JK(HME) of 2020 dated 11.02.2020;

**AND WHEREAS,** vide letter No. ES-3/4901/453 dated 23.04.2022, Director, Health Services, Jammu has forwarded the case of Dr. Bhushan Lal Gigoo, I/C Consultant Anaesthesia to the Administrative Department for settlement of his period of unauthorized absence w.e.f. 01.02.2014 to 25.05.2015;

**AND WHEREAS,** the case was placed before the Departmental Designated Committee in its meeting held on 02.02.2023. The Committee examined the case and recommended as under:-

***"i) treat the period of un-authorized absence w.e.f. 01.02.2014 to 25.05.2015 in favour of Dr. Bhushan Lal Gigoo,, Medical Officer (now Consultant Anaesthesia) as Dies Non, subject to the condition that the said doctor was not involved in any subversive activities as well as he was not employed in any Government/Private sector and no departmental enquiry is pending against him, for which an affidavit authenticated by 1st Class Judicial Magistrate shall be obtained by the Directorate of Health Services, Jammu from the concerned doctor.***

***Besides, the concerned doctor shall be warned not to leave his place of posting for any occasion in future un-authorizedly, for which disciplinary action shall be initiated against him without any further notice".***

**NOW, THEREFORE,** on the recommendation of the Departmental Designated Committee, sanction is hereby accorded to treat the period of un-authorized absence **w.e.f. 01.02.2014 to 25.05.2015** in favour of Dr. Bhushan Lal Gigoo, the then Medical Officer (now Consultant Anaesthesia) as '**Dies Non**', subject to the

condition that the said doctor was not involved in any subversive activities as well as he was not employed in any Government/Private sector and no departmental enquiry is pending against him, for which an affidavit authenticated by 1st Class Judicial Magistrate shall be obtained by the Directorate of Health Services, Jammu from the concerned doctor.

Besides, the concerned doctor is warned not to leave his place of posting for any occasion in future un-authorizedly, for which disciplinary action shall be initiated against him without any further notice.
