The appointment of the above candidates shall be subject to following terms and conditions:-

1. The above candidates shall report to Principal, Government Medical College, Srinagar. In case of failure of the appointees to join within a period of twenty one (21) days from the date of issuance of this appointment order, they shall forego their appointment, which shall be deemed to have been cancelled *ab-initio* without any further notice.
2. The appointees shall be allowed to join only on production of following documents/certificates in original:-

- a. Date of Birth Certificate.
- b. Qualification Certificates.
- c. Domicile Certificate.
- d. Health Certificate from the Standing Medical Board.
- e. Reserved Category Certificate.
- f. Any other documents as required under rules.

The appointment of the above candidate as Lecturer shall further be subject to the verification/genuineness of the qualification certificates/ Reserved Category Certificate from the concerned issuing authorities. The salary of the appointees shall not be drawn and disbursed to them unless satisfactory reports in this regard are received in their favour.
4. The appointment of the above candidates shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.
5. The appointees shall be on probation for a period of two (02) years.
6. The seniority/promotion prospects of the appointees shall be maintained in the Department of Psychiatry, Government Medical College, Srinagar.
7. The interim arrangement, if any, made on contract/deputation or on academic arrangement basis against the above post, shall be deemed to have been terminated forthwith.
8. The inter-se seniority of the appointees shall be determined in accordance with the merit assigned by JKPSA.
9. The appointment of the above candidates shall be subject to outcome of the writ petition(s), if any, pending before any Competent Court of Law.
