**Subject:** Engagement as Assistant Professor in discipline of General Medicine in Government Medical College, Kathua, on academic arrangement basis, in terms of S.O 364 of 2020 dated 27.11.2020.

As recommended by the Selection Committee, sanction is, hereby, accorded to the engagement of **Dr. Vishal Singh Thakur** S/O Bhushan Singh R/O Ward No. 01, H. No. 137 Kathua against the post of Assistant Professor in the Discipline of General Medicine in Government Medical College, Kathua, on academic arrangement basis, in terms of the Jammu and Kashmir Medical and Dental Education (Appointment on Academic Arrangement Basis) Rules, 2020, notified vide S.O 364 of 2020 dated 27.11.2020.

The engagement of the above candidate is subject to the following conditions:

- (1) The candidate shall report to the Principal, Government Medical College, Kathua for joining within a period of twenty-one (21) days, from the date of issuance of this order, failing which his engagement as such shall stand cancelled without any further notice.
- (2) The arrangement shall be purely on temporary basis and shall not confer upon the candidate any special claim/ right for his appointment against the said post on regular basis as and when the same are filled under rules.
- (3) The candidate shall have to execute an agreement with the Government on the prescribed form in terms of S.O 364 of 2020 dated 27.11.2020. The engagement shall be for a period of one year or till the post is filled-up on regular basis on the recommendations of Jammu and Kashmir, Public Service Commission, whichever is earlier.
- (4) The above engagement shall be regulated under other terms and conditions as specified in S.O-364 dated 27.11.2020. The engagement so made on academic arrangement basis shall be extendable upto maximum of six years (one year at a time and subject to good performance and conduct) or till selection/promotion is made in accordance with the rules of recruitment governing the post, whichever is earlier and the extension so granted under these rules shall not be beyond a period of six years under any circumstances.
- (5) The salary in favour of the engaged faculty shall not be released unless a satisfactory report is received from the Criminal Investigation Department, J&K.
