

- b. the withdrawal of DDO powers of Medical Superintendent, District Hospital, Udhampur and their delegation to Chief Accounts officer, Government Medical College, Udhampur to operate upon the funds released / to be released by the competent authority.

It is further ordered that the DDO powers of the B.Sc Nursing Colleges shall be exercised by the respective Chief Accounts Officer(s) of Government Medical Colleges till such time, the Principal(s) of the B.Sc Nursing College(s) is / are posted by the competent authority.

The sanction shall be subject to the following conditions:

1. That the DDO code shall be allotted by Accountant General, J&K, in favour of the DDO(s) concerned.
2. That the funds allotted under relevant Head of account and placed at the disposal of DDO concerned shall be utilized in accordance with the laid down rules as contained in GFRs-2017 and other required formalities and circular instructions issued by the Finance Department from time to time.
