In terms to Rule 61(1), Rule 62(a) & Rule 73(1) of the J&K Civil Service (Leave) Rules, 1979 read with SRO-346 dated 17.10.2012 & SRO-274 dated 30.05.2013, sanction is, hereby, accorded to the grant of study leave in favour of Dr. Meenakshi Kundan, Medical Officer, NTPHC Raipur for undergoing MD in Pathology at Government Medical College, Jammu for a period of one (01) year (out of three years) w.e.f. 26.08.2023 in the first instance, subject to the following conditions that:-

- iv. The doctor shall submit the certificate of examination of 1st year passed before the Administrative Department before seeking extension in study leave;and
- v. That the doctor shall comply with all other conditions as laid down in study leave rules as amended from time to time.
