WHEREAS, Dr. Junis Ali, Medical Officer belonging to J&K Health & Family Welfare (Gazetted) Service represented in the Administrative Department through concerned Directorate for grant of NOC in his favour for allowing him to apply/appear against the faculty post at AIIMS Vijaypur, Samba;

AND WHEREAS, vide communication No. HD-Gaz0Gen/405/2022-02 dated 06.10.2023, the department granted NOC in favour of Dr. Junis Ali, Medical Officer to apply/appear in interview against the post of Assistant Professor at AIIMS, Vijaypur, Samba. However, the same was subject to the condition that in case of his selection, he shall formally apply for permission under relevant rules/norms before joining;

AND WHEREAS, the Director, Health Services, Jammu vide communication No. DHSJ/ES-3/4007 dated 04.01.2024 informed the department that Dr. Junis Ali, Medical Officer has been selected as Assistant Professor in the Department of Physical Medicine and Rehabilitation at AIIMS Vijaypur, Samba and he has requested for acceptance of technical resignation w.e.f 15.01.2024 from the J&K Health & Family Welfare (Gazetted) Service.

AND WHEREAS, Article-201 of J&K CSR. Vol-1, provides:-

"Resignation of an appointment to take up another appointment in which service counts, is not to be held to be a resignation of the Government Service, provided the consent of the former departmental superior is obtained to accepting, such employment."

Now, Therefore, in terms of Article-201 of J&K CSR. Vol-1 the resignation tendered by Dr. Junis Ali, Medical Officer from J&K Health & Family Welfare (Gazetted) Service is, hereby, accepted w.e.f 15.01.2024 on his own request and his lien in the J&K Health & Family Welfare (Gazetted) Service shall be deemed to have been terminated.
