As recommended by the J&K Public Service Commission, sanction is, hereby, accorded to the temporary appointment of **Dr. Anil Raina** S/O Girdhari Lal Raina R/O VH. No. C 62 Extn 4, Colonel Colony, Bohri Jammu, under OM Category, as Assistant Professor in the discipline of Pathology in Government Medical College, Udhampur, in the Pay Level-11 (67700-208700), subject to following terms and conditions:

1. The above candidate shall report to Principal, Government Medical College, Udhampur. In case of failure of the appointee to join within a period of 21 (twenty-one) days from the date of issuance of this appointment order, he shall forego his appointment, which shall be deemed to have been cancelled *ab-initio* without any further notice.
2. The appointee shall be allowed to join only on production of following documents/certificates in original:-

- a. Date of Birth Certificate.
- b. Qualification Certificates.
- c. Domicile Certificate.
- d. Health Certificate from the Standing Medical Board.
- e. Any other documents as required under rules.

3. The appointment of the above candidate as Assistant Professor shall further be subject to the verification/genuineness of the qualification certificates from the concerned issuing authorities. The salary shall not be drawn and disbursed to him unless satisfactory reports in this respect are received in his favour.
4. The appointee shall be on probation for a period of two years.
5. The appointment shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.
6. The inter-se seniority of the candidate shall be determined in accordance with the merit assigned by J&K Public Service Commission.
7. The interim arrangement, if any, made on contract/deputation or on academic arrangement basis against the above post, shall be deemed to have been terminated forthwith.
8. The appointment of the above candidate shall be subject to outcome of the writ petition(s), if any, pending before any Competent Court of Law.
