Subject: Settlement of authorized/unauthorized absence period in favour of Ms. Anita Malgotra, Senior Staff Nurse, Government Medical College & Associated Hospital, Jammu.

WHEREAS, Ms. Anita Malgotra was appointed as Junior Staff Nurse at Government Medical College and Associated Hospital, Jammu vide Order No. 144-AHJ of 2010 dated 25.05.2010 and submitted her joining report in Government Medical College, Jammu on 14.06.2010;

AND WHEREAS, she was appointed as Senior Staff Nurse vide order No. 84-AHJ of 2017 dated 13.06.2017 and submitted her joining report on 14.06.2017 in the office of Medical Superintendent, SMGS, Hospital Jammu;

AND WHEREAS, on 14.11.2017, Medical Superintendent SMGS Hospital, Jammu received an application form along with an Earned Leave Form submitted by Ms. Anita Malgotra, Sr. Staff Nurse duly endorsed by Matron SMGS Hospital Jammu, wherein the applicant requested to relieve her for undergoing higher studies i.e M.Sc Nursing;

AND WHEREAS, Medical Superintendent, SMGS Hospital Jammu issued several Notices to the official as she did not apply for higher studies through proper channel and proceeded to undergo MSc Nursing unauthorizedly;

AND WHEREAS, vide No. SMGSH/2018/NS/NPS/7748-51 dated 13.08.2018, last and final notice was issued by the Medical Superintendent, SMGS Hospital Jammu, wherein, the official was directed to resume the duties within seven days, otherwise,

recommendation with regard to termination of her services shall be extended to higher authority without any further notice under Article 128 of J&K Civil Services Regulations, Volume-I, but the official did not resume her duties;

AND WHEREAS, after completion of M.Sc Nursing, the said official submitted her joining report on 22.11.2019 in the office of Principal, Government Medical College & Associated Hospital, Jammu and the then Principal, Government Medical College & Associated Hospital, Jammu allowed the official to join the duties vide order No. 214-AHJ of 2020 dated 17.03.2020;

AND WHEREAS, vide letter No. AHJ/N/S/2021/7287 dated 17.03.2022, Principal, Government Medical College & Associated Hospital, Jammu forwarded the case of Ms. Anita Malgotra, Senior Staff Nurse regarding settlement of her unauthorized absence period w.e.f. 14.11.2017 to 21.11.2019 to the Administrative Department for further necessary action in the matter;

AND WHEREAS, the case was placed before the Departmental Designated Committee in its meeting held on 02.02.2023. The Committee deliberated upon the case and recommended as under:

"i) to treat the period of undergoing M.Sc Nursing w.e.f. 14.11.2017 to 21.11.2019 in favour of Ms. Anita Malgotra Sr. Staff Nurse as "Dies Non", subject to the condition that the said official was not involved in any subversive activities as well as she was not employed in any Government/Private sector and no departmental enquiry is pending against her, for which an affidavit authenticated by 1st Class Judicial Magistrate shall be obtained by the Principal, GMC, Jammu from the concerned official.

Besides, the concerned official shall be warned not to leave her place of posting for any occasion in future un-authorizedly, for which disciplinary action shall be initiated against her without any further notice".
