In continuation of Government Order No. 714-JK(HME) of 2023 dated 01.09.2023 and on the recommendations of J&K Public Service Commission, sanction is, hereby, accorded to the temporary appointment of Dr. Shiffali Sarngal D/O Basant Ram R/O 39 Rajinder Nagar Jammu, under SC Category, as Assistant Professor in the discipline of Pathology in Government Medical College, Udhampur, in the Pay Level-11 (67700-208700), notionally w.e.f. 01.09.2023, subject to following terms and conditions:

- 1. The above candidate shall report Principal, Government Medical College, Udhampur. In case of failure of the appointee to join within a period of 21 (twenty-one) days from the date of issuance of this appointment order, she shall forego her appointment, which shall be deemed to have been cancelled ab-initio without any further notice.
- 2. The appointee shall be allowed to join only on production of following documents/certificates in original:
 - Date of Birth Certificate.
 - b. Qualification Certificates.
 - c. Domicile Certificate.
 - d. Reserved Category Certificate.
 - e. Health Certificate from the Standing Medical Board.
 - f. Any other documents as required under rules.

- 3. The appointment of the above candidate as Assistant Professor shall further be subject to the verification/genuineness of the qualification certificates/Reserved Category Certificate from the concerned issuing authorities. The salary shall not be drawn and disbursed to her unless satisfactory reports in this respect are received in her favour.
- 4. The appointee shall be on probation for a period of two years.
- 5. The appointment shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.
- The inter-se seniority of the candidate shall be determined in accordance with the merit assigned by J&K Public Service Commission.
- 7. The interim arrangement, if any, made on contract/ deputation or on academic arrangement basis against the above post, shall be deemed to have been terminated forthwith.
- The appointment of the above candidate shall be subject to outcome of the writ petition(s), if any, pending before any Competent Court of Law.
