The appointment of the aforementioned candidates shall be subject to following terms and conditions:

1. The above candidates shall report to Principal, Government Medical College, Udhampur. In case of failure of the appointees to join within a period of 21 (twenty-one) days from the date of issuance of this appointment order, they shall forego their appointment, which shall be deemed to have been cancelled *ab-initio* without any further notice.
2. The appointees shall be allowed to join only on production of following documents/certificates in original:-

- a) Date of Birth Certificate.
 - b) Qualification Certificates.
 - c) Domicile Certificate.
 - d) Reserved Category Certificate (wherever applicable).
 - e) Health Certificate from the Standing Medical Board.
 - f) Any other documents as required under rules.
3. The appointment of the above candidates shall further be subject to the verification/ genuineness of the qualification certificates/ Reserved Category Certificate (wherever applicable) from the concerned issuing authorities. The salary shall not be drawn and disbursed to them unless satisfactory reports in this respect are received in their favour.
 4. The appointees shall be on probation for a period of two years.
 5. The appointment shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.
 6. The inter-se seniority of the candidates shall be determined in accordance with the merit assigned by the JKPSC.
 7. The interim arrangement, if any, made on contract/deputation or on academic arrangement basis against the above posts, shall be deemed to have been terminated forthwith.
 8. The appointment of the above candidates shall be subject to outcome of the writ petition(s), if any, pending before any Competent Court of Law.
